FLDIGI is the preferred sound card software because FLAMP and FLMSG are used for message handling. This is a training net for new users, so operator error is expected and well tolerated.

Treasurer's Report:

David K2DSL provided current account balance. Report accepted (Warren K2UFM, Larry WA2ALY).

President's Report:

Jim K2ZO reported that the Foxhunt on May 13 went well, even though no teams located the fox.

The Hamfest is May 27. In the event of rain, we may try to postpone the event until the following Saturday. Details will be on the BARA website.

Portable Day is May 13. Location is at Memorial Field in Fair Lawn.

Net Reports: Jim K2ZO reported that the 10 meter and 2 meter are OK. Gordon W2TTT stated that the tech net is going very well.

Old Business:

K2ZO restated the need for BARA to purchase a new sound system that was discussed at the December 2016 meeting. In addition to club activities, the sound system would be used at town events where Jim represents BARA.

A motion was made by Bruce WG2Y to purchase a new sound system, in the amount of up to \$400.

Details will be discussed at the Business Meeting on June 4th. Please attend and signup for a specific task. Tasks include station operators/loggers, site setup and takedown, moving equipment to/from the BARA garage, cooking, providing food and water. In addition, there are opportunities to earn bonus points for various activities. Bonus points add to the QSO total points for a club score and require minimal physical activity.

BARA stations will use the N1MM+ logging program. A presentation will be given at the June business meeting on the use of N1MM+ for Field Day. Also please see the following link to a Utube presentation on basic Field Day operation and logging.

The Field Day bonus point available are:

Media Publicity: 100 bonus points may be earned for attempting to obtain publicity from the local media. A copy of the press release, or a copy of the actual media publicity received (newspaper article, etc.) must be submitted to claim the points.

Public Information Table: 100 bonus points for a Public Information Table at the Field Day site. The purpose is to make appropriate handouts and information available to the visiting public at the site.

Message Origination to Section Manager: 100 bonus points for origination of a formal message to the ARRL Section Manager or Section Emergency Coordinator by your group from its site.

Message Handling: 10 points for each formal message originated, relayed or received and delivered during the Field Day period, up to a maximum of 100 points. A person is needed to be available in the public area from 2 PM to 5 PM on Saturday to accept messages from members and non members for later transmission into a traffic net.

Satellite Operation: 100 bonus points for successfully completing at least one QSO via an amateur radio satellite during the Field Day period.

Alternate Power: 100 bonus points for Field Day groups making a minimum of five QSOs without using power from commercial mains or petroleum driven generator.

W1AW Bulletin: 100 bonus points for copying the special Field Day bulletin transmitted by during its operating schedule during the Field Day weekend.

Educational activity bonus: 100-point bonus may be claimed if your operation includes a specific educational-related activity.

Site Visitation by an elected governmental official: 100-point bonus if your site is visited by an elected government official.

Site Visitation by a representative of an agency: 100-point bonus if your Field Day site is visited by a representative of an agency served by ARES in your local community (American Red Cross, Salvation Army, local

Emergency Management, law enforcement, etc.) as the result of an invitation.

GOTA Station: This station permits non-licensed individuals to make contacts under the supervision of the GOTA Coach. 20 bonus points are earned for every twenty QSO's up to a maximum of 500 points.

GOTA Coach: The GOTA Coach supervises the operator of the station, doing such things as answering questions and talking them through contacts, but may not make QSOs or perform logging functions. The GOTA Coach is the Control Operator and must hold a General or Extra Class license. 20 bonus points are earned for every 20 QSO's made by GOTA operators, up to a maximum of 100 points.

Web submission: A 50-point bonus may be claimed by a group submitting their Field Day entry via the www.b4h.net/cabforms web site.

Field Day Youth Participation: A 20-point bonus (maximum of 100) may be earned by any Class for each participant age 18 or younger at your Field Day operation that completes at least one QSO.

Safety Officer Bonus: A 100-point bonus may be earned by having a person serving as a Safety Officer for those groups setting up Class A stations. This person must verify that all safety concerns on the Safety Check List (found in the ARRL Field Day Packet) have been adequately met.

Social Media: 100 points for promoting your Field Day activation to the general public via an active, recognized and utilized social media platform (Facebook, Twitter, Instagram, etc).

Field Day is only a month away, but with some thought and preparation earning this bonus points can become manageable tasks. For example, staffing a table on Saturday afternoon to accept messages from members and the public. These will be entered in to a traffic network later in the afternoon.

FCC AND OSHA RELEASE COMMUNICATIONS TOWER BEST PRACTICES GUIDE

The FCC and OSHA have announced the release of a free publication, **Communica-***tions Tower Best Practices Guide*.

While aimed more at those who tend commercial communication towers, the guide offers guidance applicable to the Amateur Radio community and contractors working on Amateur Radio antenna support structures. The FCC said the guide was a result of two tower safety workshops.

Please consider operation from your home or mobile radio.

The objective is to work as many amateur stations in as many different grid squares as possible using authorized frequencies above 50 MHz. The exchange is your grid square.

K2AMI usually operates a high power station from his QTH. He may use the callsign K2BAR.

SSB operation will be on 50, 144, 222 and 432 MHz.

FM operation will be on 146.580, 223.500, and 446.000 simplex.

If you operate mobile you are considered a "Rover" station and you should indicate "rover" after your call. Log rover stations as callsign/R. **Rover stations may work** the same stations multiple times, once for each originating grid square.

Stations operating Rover in this area have the opportunity to operate from four grid squares in about a five mile route in River Vale. **On this route contacts may be** made from grid Squares FN20, FN21, FN30 and FN31. Directions for the four grid loop are:

START at the intersection of Westwood Ave and Rivervale Rd in Rivervale, NJ (FN20).

Go NORTH on Rivervale Rd. (enter FN21 at about 0.5 miles). In 1.3 miles turn RIGHT onto Old Tappan Rd (enter FN31 at about 0.6 miles).

In 1 mile turn RIGHT onto Washington Ave.

In 0.5 miles turn RIGHT onto Westwood Ave (enter FN30 at about 0.3 miles)

In 0.9 miles Westwood Ave turns right Continue on Westwood Ave for 0.7 miles to starting point (enter FN20 at about 0.4 miles). See map on Page 7

A repeater may NOT be used to make calls or schedule calls during the contest.

The logging requirements for the contest or minimal. For each contact record the date, UTC time, your grid square, the received grid square, and the received call sign. Note, the date is based on the UTC clock. If you are not familiar with submitting a log, send me the information and I will format a log and submit it for you. A log in Excel format is preferred, but a text or paper log is acceptable. If you submit your own log to the ARRL please include "Bergen ARA" as the club name.


